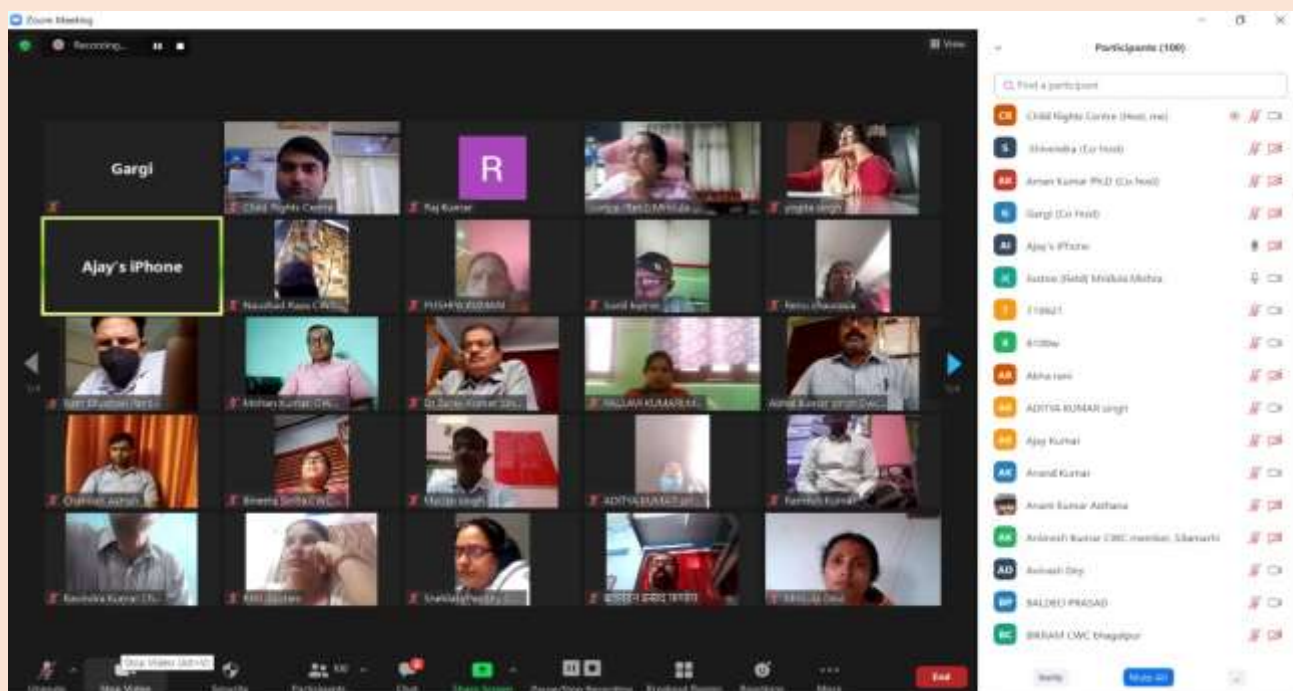
Editorial

सर्वोच्च न्यायालय के दिशानिर्देश और सीडब्ल्यूसी की जिम्मेदारी दिनांक 20 जुलाई 2021 को आयोजित ऑनलाइन सत्र



नए कानून के अलोक में बाल विकास समितियों के कोविड की महामारी से जूझने की क्षमता से सम्बंधित कई आदेश माननीय सर्वोच्च न्यायालय ने जारी किये हैं। इनमें से विशेष रूप से दिनांक 03.04.20 को जारी किया गया “सुओ मोटो रिट पेटीशन (सिविल) संख्या 4” उल्लेखनीय है। इस आदेश में निम्नलिखित मुख्य बिंदु आते हैं:

- बाल विकास समितियों को कोविड-19 के अलोक में अपनी जांच/निगरानी के दौरान बच्चे अथवा बच्चों के लिए सर्वोत्तम क्या है तथा उनके स्वास्थ्य एवं सुरक्षा की व्यवस्था आदि का ध्यान रखने के सम्बन्ध में कार्य करना होगा।
- विशेष ऑनलाइन अथवा वीडियो के जरिये वैसे बच्चे जो बाल सुधार गृहों अथवा एसएए में हैं, उन्हें कोविड-19 से जुड़े खतरों से बचाया जाए।
- बच्चों के लिए परिवार के बाहर की वैकल्पिक व्यवस्था अंतिम विकल्प हो, इस हेतु पहले से ही रोकथाम के प्रयास किये जाएँ।
- फोन जैसे माध्यमों से बच्चों और उनके परिवारों को परामर्श जारी रखा जाए और जिला बाल सुरक्षा समितियों, वैकल्पिक व्यवस्था और गोद लेने जैसी व्यवस्थाओं में बच्चों से संपर्क और निगरानी रखी जाए।
- हिंसा, विशेष रूप से लिंग आधारित या यौन हिंसा सम्बन्धी घटनाओं में कोविड से जुड़ी तनाव और उत्तेजना या बीमारी के भय से बढ़ावा हो सकता है। बाल कल्याण समितियों को व्हाट्स एप्प, वीडियो कॉन्फ्रेंसिंग, और टेलीफोन के जरिये निगरानी रखनी है ताकि ऐसी घटनाओं की रोकथाम की जा सके।
- जिन परिवारों ने बच्चे गोद लिए हैं, उन्हें भी कोविड-19 के संक्रमण से बचाव पर जानकारी पहुंचानी है तथा समय समय पर उनके शारीरिक एवं मानसिक स्वास्थ्य की जानकारी लेनी है, साथ ही उन्हें ये भी बताना है कि लक्षणों की स्थिति में क्या करना है।

इन आदेशों के अलोक में समाज कल्याण विभाग, बिहार सरकार ने चाणक्य राष्ट्रिय विधि विश्वविद्यालय, पटना एवं यूनिसेफ के माध्यम से दिनांक 20 जुलाई, 2021 को एक ऑनलाइन प्रशिक्षण सत्र का आयोजन किया। इस प्रशिक्षण

सत्र में अपने क्षेत्र के जाने माने विद्वानों और विशेषज्ञों ने बाल कल्याण समिति के सदस्यों को नए निर्देशों एवं माननीय सर्वोच्च न्यायालय की अपेक्षाओं से परिचित करवाया।

जस्टिस (सेवानिवृत्त) मृदुला मिश्रा (माननीय कुलपति – चाणक्य राष्ट्रीय विधि विश्वविद्यालय, पटना)

श्री राज कुमार, श्री शिवेंद्र पंड्या तथा वक्ताओं और सभी उपस्थित प्रतिभागियों का स्वागत करने के बाद जस्टिस मृदुला मिश्रा ने कहा कि सबसे पहले तो हमें पता करना होगा कि कितने बच्चों ने अपने माता-पिता या अभिभावकों को खो दिया है। घर के इकलौते कमाने वाले सदस्य की मृत्यु के कारण कितनों को आर्थिक मदद की जरूरत है ये भी मालूम करना होगा। जो स्कूल जाने वाले बच्चे हैं, उनके माँ-बाप की मृत्यु की स्थिति में वो प्राइवेट या निजी स्कूल में हैं, उनकी गिनती तथा उनके लिए जिला स्तर पर क्या व्यवस्था हुई, ये देखना भी अब बाल कल्याण समिति के काम का हिस्सा है। ध्यान रखा जाए कि कहीं किसी की पढ़ाई छूटी तो नहीं? माननीय सर्वोच्च न्यायालय ने भी आंकड़े मांगकर यही देखने का प्रयास किया है कि बाल कल्याण समिति ने क्या इन चीजों की पूछताछ एवं जांच की है?

जुविनाइल जस्टिस फण्ड राज्यों ने लागू की है या नहीं? अगर की है तो भोजन, स्वास्थ्य, साफ़-सफाई और शिक्षा के क्षेत्र में उस निधी से क्या व्यवस्था की गयी है? उन्होंने इसकी जांच भी करने को कहा कि जिला मुख्यालयों को दस लाख की निधी मिली या नहीं, और अगर मिली हो तो उसमें से खर्च की क्या स्थिति है? माननीय सर्वोच्च न्यायालय का आदेश था कि इस निधी को पूरा-पूरा बच्चों की बेहतरी पर खर्च किया जाए। उन्होंने कहा कि कोविड काल में माँ-बाप के खोने जैसी स्थिति के लिए हमारे बाल कल्याण समिति के सदस्य तैयार हैं या नहीं है? कोई प्रशिक्षण मिला है? अगर नहीं मिला तो कैसे इसका प्रबंध किया जाए इसपर माननीय सर्वोच्च न्यायालय के दिशानिर्देशों के अनुरूप, ध्यान देना जरूरी है। उन्होंने आशा व्यक्त की कि वक्ता (रिसोर्स पर्सन) पूरी तैयारी के साथ आये होंगे इन सभी मुद्दों की जानकारी हमें देंगे।

इस कार्यक्रम को सफल बनाने और सभी 160 से अधिक प्रतिभागियों की सहभागिता कार्यक्रम में सुनिश्चित करने के लिए उन्होंने अजय कुमार (सीनियर स्टेट कंसलटेंट, डीएसडब्ल्यू एवं यूनिसेफ बिहार) एवं चन्दन कुमार (प्रोग्राम कोऑर्डिनेटर, चाइल्ड राइट्स सेक्टर, सीएनएलयू) के योगदान का उल्लेख करते हुए उनके प्रति भी आभार व्यक्त किया।

Report of CCADR (Academic Year: 2021-22)

The Chanakya Centre for Alternative Dispute Resolution (CCADR) has been established at Chanakya National Law University, Patna, in the year 2021, with the objective to promote academic research on themes pertaining to the resolution of disputes.

Functions of the Centre

To promote a general culture of research and discussion of ADR in the University.

To run a Bi-annual peer-reviewed Journal on ADR, which would cater as a common platform to publish research work undertaken by students, academicians, professionals from within and outside University.

To provide an online platform for publishing regular updates in the field of ADR weekly, short submissions, research material, case comments, and policy analysis in the field of ADR.

To bridge the gap between University and Industry by organizing seminars, conferences, round table discussions, conclaves, guest lectures, and webinars by industry experts.

To conduct workshops and non-credit practical courses to impart practical and technical knowledge of the industry to University's students.

To establish and organize Certificate Courses in ADR for students, academicians, and young professionals from within and outside University.

To conduct competitions at the national and international levels in ADR.

Activities Undertaken So far

- I.** The **CCADR** was inaugurated on **12th September 2021** by a way of the virtual inaugural ceremony. The session was graced by the attendance of *Chief Guest, Mr. Ratan K. Singh* (a senior advocate specializing in arbitration and having associations with several national and international arbitral institutions), *Hon'ble Vice-Chancellor* of CNLU, **Justice Smt. Mridula Mishra**, faculty members of CCADR, and 96 students from CNLU as well as other universities.
- II.** On 14th November 2021, the CCADR conducted a Guest Lecture on **“Judicial Intervention: An Aid Or Barrier To Arbitration In India?”**. The *guest speaker* for the session was **Mr. Akash Gupta** (Lecturer, JGLS, Arbitrator & Conciliator).
- III.** A *Guest Lecture* on **“Section 34: An Appeal in Disguise”** on 04th December 2021. **Ms. Iram Majid**, the Executive Director of APCAM and a certified Arbitrator and Mediator was the speaker of the session.

Inauguration of Sehat Centre, funded and developed with joint effort of Bihar State Health Society and Bihar State AIDS Control Board, Department of health, Government of Bihar, was held on 1 July 2021, 11.00 am in the academic block of Chanakya National law University Patna, by Vice Chancellor, Honourable Justice Shrimati Mridula Mishra, in presence of faculty members and staffs of the University and Shri Ashish Sinha ji,

(don't know designation). Sharing her thoughts, honourable vice chancellor appreciated the efforts of government in establishing these centres at a critical time and suggested that a proper activity chart shared so that the same can be incorporated in the academic calendar of the university for effective implementation of the centre's mandate. Such centres would go a long way in enlightening young people on various important health issues and providing them right guidance and information on issues relating to health as well as gender.

The Centre's mandate is to increase awareness among young people regarding sexual and reproductive health, regarding various health services of the government and connect them to youth clinics, develop positive attitude towards gender equality, develop life skills, spread awareness regarding HIV AIDS, encourage voluntary blood donation, provide important health related information like diet, mental health, drug addiction, disadvantages of young age pregnancy etc.

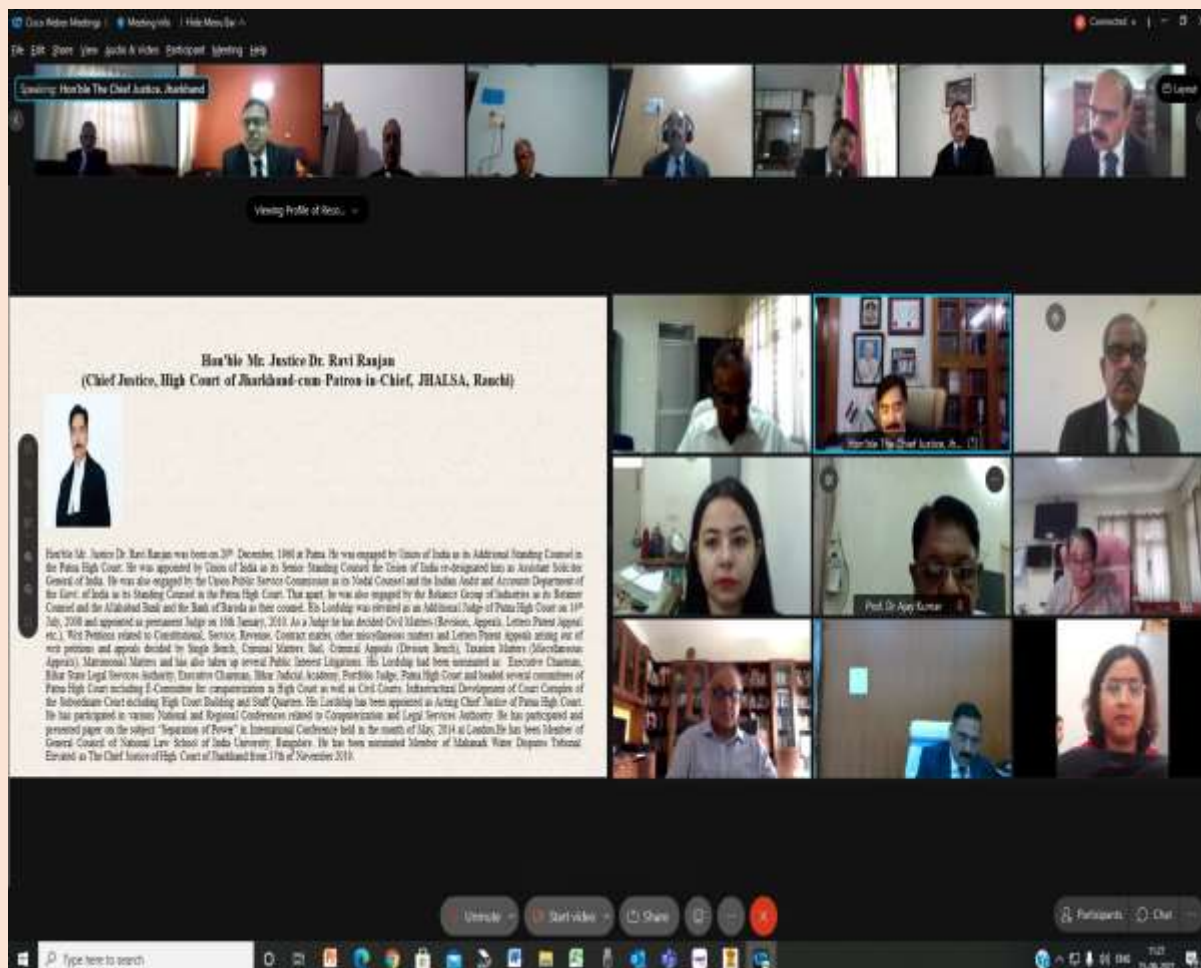
