## Minutes of the Meeting:

- 1. The University will initiate Administrative Audit and internal Audit Committee will be constituted.
- 2. The University will move towards energy conservation through LED Bulbs and solar energy appliances will be installed phase wise. The Energy committee shall be constituted.
- 3. The University will undergo Environment Audit. For this purpose, necessary steps shall be taken to install Rainwater harvesting mechanism and solid waste management and plantation also. In new building, rain water harvesting shall be installed compulsorily.
- 4. The Academic Audit will be started. All the necessary steps shall be taken for this purpose.
- 5. District Court Advocacy (Moot court) shall be conducted every semester in each paper of Law. In non-Law Papers debates shall be organised every semester and records shall be kept.
- 6. Drafting and Pleadings shall be t taught in each paper of law every semester and each question paper shall carry one question for drafting in that subject for 5 -10 marks.
- 7. Publication of CILPE (Creative-Innovation -in Legal Professional Education) as in-house annual report and contribution by faculty and students-their achievements (As newsletter).
- 8. All faculty requires to publish at least one article/research paper in the peer reviewed journal every year compulsorily.
- 9. Internship certificate and daily attendance record shall be submitted by each student on return from internship training to the Internship committee convenor compulsorily.
- 10. Medical insurance facility for students has been proposed. It shall be discussed with the insurance companies. The Healthcare Committee shall be constituted.
- 11. It has been proposed to convert all class rooms into smart class phase wise. Audio-visual, projectors shall be made available in each class room.
- 12. It is resolved to convene meetings of each committee every month to assess the work progress towards completion.
