Dear Candidates,

Greetings from CNLU!

Based on performance at the CLAT-2024 Examination held on 03rd December, 2023, the candidates who are provisionally selected by the Consortium of National Law Universities, Bengaluru, for counselling for admission in the Five Year Integrated B.A., LL.B. (Hons.)/ B.B.A., LL.B. (Hons.) Degree Course at Chanakya National Law University, Patna are directed to pay:

- (i) <u>Rs. 2,06,970/-</u> (Two Lakh Six Thousand Nine Hundred Seventy only) in the case of **General Category** candidates who have already paid Rs. 50,000/- (*Rs. 30,000/- Counselling Registration Fee and Rs. 20,000/- for Confirmation Fee*) to CLAT Consortium, 2024; **and**
- (ii) <u>Rs. 2,16,970/-</u> (Two Lakh Sixteen Thousand Nine Hundred Seventy only) in the case of **ST/ SC/EBC/ BC/ EWS/ PWD candidates**, who have already paid Rs. 40,000/- (*Rs. 20,000/- Counselling Registration Fee and Rs. 20,000/- for Confirmation Fee) to CLAT Consortium*, 2024.

Payment has to be made till 10th June, 2024 by the candidates who would choose the Freeze option for CNLU, Patna in the fourth and fifth allotment lists through the following ICICI Payment Gateway Link, failing which their claim of admission in Academic Year 2024-25 would be forfeited:

(NOTE: The candidates who have chosen the Freeze option for CNLU in the first three allotment lists and have already paid are requested not to pay again.)

Candidates shall have to **upload** the **soft / scanned copies** of following documents as given below on CLAT Consortium Portal, 2024 only within the **stipulated time as given by the Consortium of National Law Universities, Bengaluru:-**

- 1. Grade 10 statement of marks*
- CLAT 2024 Admit Card*
- 3. Grade 12 statement of marks**

- 4. Character Certificate/Conduct Certificate from the Educational Institution last attended**
- 5. Transfer/Migration Certificate from the Educational Institution last attended**
- 6. PWD Certificate issued by the competent authority, if applied and allotted under PWD Category*.
- 7. Caste Certificate (EBC/BC/SC/ST) issued by competent authority of Govt. of Bihar (Applicable for the reserved category candidates only), if applied and allotted under the reserved category*.
- **8.** Certificate of Economically Weaker Section (EWS) issued by competent authority of Govt. of Bihar for the last Financial Year (2023-24) (*Applicable for the EWS category candidates only*), if applied and allotted under the reserved category*.

NOTE:

- Items marked with * are mandatory.
- Items marked with ** are also mandatory but candidates who have appeared in 10+2 (Intermediate) examination of 2024 and are not able to submit these certificates before 23rd May, 2024 are directed to submit hard copy of these documents at the time of admission at CNLU, Patna. However, candidates who have already passed 10+2 examination must upload these certificates which are marked with **.

At the time of admission all provisionally admitted candidates have to bring original copies of all the above-mentioned documents, failing which their admission will stand cancelled. Candidates are requested to come along with one set of self-attested photo-copies of all the above mentioned documents also.

The date of the offline admission process for provisionally admitted candidates would be announced in the first week of June, 2024.
